Candidates should not have been born earlier than <b>24<sup>th</sup> November, 1994</b> and <b>Later than 23<sup>rd</sup> November, 2002.</b>	<b>i) Pass in the Senior Secondary Certificate (10+2) Examination with physics, chemistry and biology as subjects from a recognized Board or equivalent.</b> <b>ii) Diploma in Pharmacy from any institution of or recognized by Central or State Government.</b> <b>iii) Registered as Pharmacist under the Pharmacy Act 1948.</b>

5. The candidates whose applications are found in order, shall be issued admit cards (online) to appear in recruitment tests. Candidates have to download online admit card from ITBP recruitment website i.e. **www.recruitment.itbpolice.nic.in**. Therefore, candidates should provide genuine and functional e-mail ID and mobile number at the time of filling online application form. ITBP will not be responsible in case of non receipt of admit card due to technical and other reasons.

6. The selection process will consist of Physical Efficiency Test (PET), Physical Standard Test (PST), Written Test, Verification of Documents, Practical Test, Detailed Medical Examination (DME)/ Review Medical Examination (RME).

7. Medical Examination to assess the fitness of candidates will be conducted in terms of Uniform Guidelines for Recruitment Medical Examination for GOs and NGOs in CAPFs and AR issued vide MHA U.O. No. A.VI-1/2014-Rectt(SSB) dated 20.05.2015 and as amended from time to time by the Government.
